- 1. Open Meeting. Tim Bullard opened the meeting at 6:00 p.m.
- 2. Additions and Deletions to the Agenda: None

- 4. Scott Griswold, Ambulance Contract. Scott Griswold came to the meeting to have the members of the Selectboard sign the annual contract in person for the amount that was included in the budget and Town Meeting Warning for March 4, 2025. The contract for beach manager and the assistants were presented to the selectboard and were signed for the summer season. - 9. Minutes: Review minutes of 3/11/25. Tim motioned to approve the minutes as written, Ricky seconded. Minutes approved as written.
- 10. Highway Department:
  - a) Overweight Permits were reviewed: AmeriGas, Desrochers, Inc., Black Ox Trucking Oil Supply Corporation, Dale Percy, Suburban Propane, Structural Wood Corporation, Harrison Redi mix, Harrison Concrete, Barrett Trucking, Earnest Krusch, Camp Precast Products, Blow and Cote, Curtis Lumber. Ricky motioned to approve all overweight permits to town specifications. Clayton Seconded. Approved
  - b) Camp Road Survey: Next Steps. The board reviewed the letter that was drafted to send to the property owners on the Camp Road to present the results of the road survey. A meeting will be scheduled with the surveyor and the board and when a time is established, the letter will be sent to all the Camp Road property owners 2 weeks prior to the scheduled meeting.
  - c) Other. A temporary bridge was installed at the Boy Scout Camp Road during the construction of the new box culvert. When removed, the stream bank was compromised and has started to scour and needs attention. The bank will need to addressed and fixed when they come back to finish the cleanup in the Spring.
