- 2. Additions and Deletions to the Agenda: None

 - a. Pam brought in pictures of the well house as some of the boards are rotting and it will need to replaced soon. The selectboard feels it will just be best to replace the whole building at this point. They are still hauling road sand for the winter to get that stock piled. Bill Allen has been hired to start the road side mowing which will take approximately 90 hours to complete all the town roads.
