- 1. Tim opened the meeting at 6pm.
- 2. Additions and Deletions to the Agenda: None
- 3. Citizens Input: None
- 4. Perry Thomas and members from Lake Eden Association came in to discuss a workshop they have planned for Friday, August 29th. They would like to plant some shade trees along the brook at Lake Eden Recreation to help with shoreline restoration. Ricky will meet Peter up at the Recreation area on Thursday to go over where and how many trees can be planted.

- 11. Highway Dept. Update:
 - a. Approve driveway permits: Two driveway permits were approved at the last meeting but needed to be signed for final approval.
 - b. Other: The road side mowing has been completed. They have been working on replacing some culverts on Blakeville road which is almost done. They finished putting the under drainage on Cooper Hill. The 2012 Freightliner is back down to Charlebois for the same issue as previously repaired. The survey markers for Camp Road have been taped and are ready to be cut. Matt emailed believing it will either be the first or second week of September for installation. The town highway pickup side-swiped a deer which caused some damage to the truck. Ricky will check with a couple different shops about pricing but will line up getting it fixed. Ricky did bring up an issue about somebody taking gravel out of the road. The selectboard asked for a letter to be sent to the land owner asking them to stop removing gravel from the roadway.
