### SELECTBOARD AGENDA

**October 28, 2025 @ 6pm**

Present at the meeting were Tim Bullard, Clayton Whittemore, Ricky Morin, Melissa Whitcomb, Molly Morin, Dan Lathrop, Kristina Brown, Trevor Bidwell

1. Tim opened the meeting at 6:00pm.
2. Additions and Deletions to the Agenda: None
3. Citizens Input: Bert Manning called this afternoon with a concern about some goats that have been on his property on North Road. The Selectboard would recommend reaching out to his neighbors to see if they are theirs. If that doesn't resolve the issue they would recommend calling the Vermont State Game Wardens.
4. Eden Youth Sports: Tim motioned to go into executive session per VSA 313 a (3) to discuss the appointment, employment, or evaluation of a public officer or employee. Clayton seconded. Motion approved. Invited were Molly, Melissa, Dan, with Dan agreeing Kristina would join. Executive session started at 6:05pm. Executive session ended at 7:20pm. No decisions were made. Tim motioned to come out of executive session. Clayton seconded. Motion approved.

Two letters of resignation came in one from Hannah Speer and the second one from Nicholas Tetreault. Ricky motioned to accept the two letters of resignation for Hannah Speer and Nicholas Tetreault. Tim seconded. Motion approved.

The Sports Committee was down to only two members. Tim asked if anybody in the room was willing to fill in as interim until it can be advertised to keep the sports running. Kristina Brown and Molly Morin expressed they would be willing. Clayton motioned to put Kristina Brown and Molly Morin on the Eden Youth Sports as interim members. Ricky seconded. Motion approved. An advertisement will be put out to ask for more volunteers.

Dan, Trevor and Kristina asked if there was an amount the committee could spend to keep basketball going. They would need uniforms and some new basketballs. Ricky motioned to let the Eden Youth Sports Committee to spend up to \$3000 on uniforms and equipment needed for basketball. Clayton seconded. Motion approved.

5. Beach Update:
  - a. Switch campsite 16 to 15: A first-time camper when looking at the site realized it would be difficult for them to get their camper in that spot and asked to be moved to site 15. The Selectboard was okay with them moving from campsite 16 to 15.
  - b. Other: The Highway crew got the docks out of the water for the season and made sure everything was locked up for the season.

8. Signed for four (4) orders.
9. Minutes: Review minutes of 10/14/25 (2): Clayton motioned to approve the minutes as written. Ricky seconded. Approved.
10. Highway Dept. Update: They have reclaimed North Road and Pike will start paving next week. They have changed the culvert on Edsel Rich Road and have one more to change on Tree Farm Road. White Road culvert has been bought and Phil Morin has said he can do the headwalls. The 2024 Western Star is down at Charlebois due to lights being on which is under warranty. The 2012 Freightliner is also going to need to go back down as the light has come back on again but the truck is still running okay right now. Road sand for the winter is not all put up yet but is close to it. The ROW markers were placed on Camp Road today.

12. Grant Update/Discussion: Finishing up the grant on Griggs Road to be submitted. The one on Blakeville is in the process of being reimbursed to us. The better back roads grant needs to be submitted by Friday. Ricky and Chad are getting estimates for us to submit.
