1. Ricky opened the meeting at 6:00pm
2. Additions and Deletions to the Agenda: Personal under other

8. Highway Dept. Update:
  - a. Winter Parking Ban: Ricky motioned to accept the parking ban as written. Clayton seconded. Motion passed.
  - b. Other: Western Star has been fixed and is back from Charlebois. North Road has been reclaimed and paved before winter. The Fidium micro trench lines have not been corrected. Melissa will look into the issue from Knowles Flat Road and see how we can get that corrected next summer. Ricky would like a letter sent out to people that have things in the right of way as a reminder to move them. Two more culverts need replacing but will be weather permitting if they are done this year or not.
