1. Dan opened the meeting at 5:00pm.
2. Citizens Input: None
3. Basketball Coaches Interviews: Dan motioned to go into executive session per VSA 313 a (3) to discuss the appointment, employment, or evaluation of a public officer or employee. Trevor seconded. Executive session started at 5:05pm. Dan motioned to come out of executive session at 7:00pm. Molly seconded. No decisions were made. Molly motioned to hire Nick Tetreault for the Kindergarten/ Preschool basketball team coach. Kristina seconded. Motion approved. Molly motioned to hire Jackie Sweetser for the 1st/ 2nd grade basketball team coach. Trevor seconded. Motion approved. Molly motioned to hire Liza Jones for the 3rd/4th grade basketball team coach. Trevor seconded. Motion approved. Molly motioned to hire Kelly Lane for the 5th/6th grade basketball team. Kristina seconded. Motion approved. Molly motioned to hire Trevor Bidwell for the 5th/6th grade basketball team with Adam Pelletier being his assistant coach. Kristina seconded with Trevor abstaining from the vote. Motion approved.
The committee discussed with Nick Tetreault about being a floating coach to help where it is needed. Dan motioned to have Nick as a floating coach. Molly seconded. Motion approved. Nick is happy to help where he is needed.
4. Review Basketball Sign-ups
 - a. Team Sizes: 5% boys had 12 kids signed up with one more being added before the season starts. 5% girls has 12 kids signed up. ¾ co'ed team has 8 kids total. ½ co'ed skills and drills has 16 kids. It was brought up to the committee that two children have the skill level to be moved to the next level team. The

children have been playing for several years with Eden and the committee said it was okay if the parents understood they were going to be playing on a harder team.

- b. Uniforms: 30 more uniforms will be ordered. We will be ordering the same uniforms as last year. Molly found them at a different company for cheaper. The committee is okay with using a different company to save money. Molly also has the opportunity to get some used basketball from Lamoille Union Middle School. We will still order a couple basketballs for game use.
 - c. Practices: Nick has been helping the committee talk with the school and create the basketball game and practice schedule. Nick will finish typing them up and get them to the committee to hand out.
5. Review Lamoille County annual meeting from Nov. 5th, 2025: Nick and Kristina went to the annual basketball meeting for Lamoille County. A few changes were made in the Lamoille County Youth Basketball guidelines. Nick and Kristina also got the games scheduled for $\frac{5}{8}$ teams, $\frac{3}{4}$ team, and $\frac{1}{2}$ team.
 6. Other: A coach meeting with the players and guardians will be held to go over procedures and expectations.
