1. Tim opened the meeting at 6:04pm.
2. Additions and Deletions to the Agenda: Dan Lathrop Resignation to EYSC: Ricky made the motion to accept Dan Lathrop's resignation from Eden Youth Sports Committee. Clayton seconded. Motion approved. The Selectboard would like to thank Dan for this time and dedication to the committee over the years and they understand his frustration with the ongoing issues that has led to his resignation.
