March 10th, 2026 6pm

1. Tim opened the meeting at 6:06pm.
2. Additions and Deletions to the Agenda: Deletion of #12 on the agenda. It is no longer needing to be discussed.
3. Citizens Input: None
4. Animal Control Update: None
5. Health Officer Update: None
6. Beach
 - a.) Beach Managers Resignation: A letter of resignation was received for Pam and Johnna. The selectboard would like to run an ad in the newspaper but would also like to reach out to Pam and Johnna to see if they would be willing to help as assistants.
 - b.) Pick a date for the Spring Lottery: This will be tabled until the next meeting.
7. Five orders were signed.
8. Minutes: Review minutes of 02/24/26 (1) and 3/3/26 (1): Ricky motioned to approve the minutes as written. Clayton seconded. Motion approved.
9. Highway Dept. Update:
 - a. Overweight Permits: Ricky motioned to approve overweight permit to town specs for G.W. Tatro Construction, Lily Transportation, Kris Bullock, N.A. Monsh, and AmeriGas. Clayton seconded. Motion approved.
 - b. Other: Ricky did receive a phone call from Vikings about the charges for fixing the 2024 Western Star. Ricky called them back to talk to them to discuss but has not received a phone call back. Ricky did reach out to the sales representative Mike from Viking to ask him how he felt. Mike advised we wait to see if they send us a bill and if they do to let him know so he can deal with it.
10. Ratify Additions and Deletions: Dan Lathrop Resignation to EYSC. Ricky motioned to approve the addition from 2/24/26 meeting. Tim seconded. Motion approved.
11. Grant Update/Discussion: Molly reminded Ricky that she needed to submit any highway grants by April 15th. Ricky said he would work on getting estimates for her to submit. We also needed to sign the amendment for the MERP grant for the office. Now we can upgrade the lighting and the ADA walk way into the building. Ricky motioned to sign the amendment. Tim seconded. Motion approved.
13. Other

- a. Restoration recording fee change: Melissa spoke on how to put more money into the restoration fund. The fee for recording will not be changed but how the office breaks it up would. Instead of \$5.00 going into the restoration fund \$7.00 would be going into the restoration fund. Ricky motioned to approve the fee change. Clayton seconded. Motion approved.
 - b. Other: Phone call to Leslie for her to bring up a couple things. Leslie received a phone call from Brave Little State which will be on the radio. The reporter had interviewed her on the asbestos mines in Eden. Leslie did ask the reporter to send it to her before they publicize it.
Her other concern was that she feels that somebody is living up in Ritterbush. The selectboard recommended to contact the College and/or the police to let them know.
